Walgreen's Back-to-School Check-In for the Chance to Win Sweepstakes

- 2. To enter the Sweepstakes via foursquare and a text message, a nominator must go to a Walgreens retail location and check-in via foursquire and thereafter text BTS to 21525 (Text Entry"). You will receive a "Thank You" text message confirming that the Text Entry has been received. You may stop receiving text messages at any time by responding "end," "stop," or "quit" to the Thank you text message or any other text message associated with the Sweepstakes. Standard text message rates apply to the Text Entry and all other mobile communications, including but not limited to additional Text Entries and notifications sent and received in connection with the Sweepstakes. A nominator can contact his/her carrier/service provider for pricing plans and details.
